## **NOTICE TO SHAREHOLDERS TRANSFER OF UNCLAIMED DIVIDEND AND EQUITY SHARES TO INVESTOR EDUCATION AND PROTECTION FUND SUSPENSE ACCOUNT (IEPF)**

This Notice is published pursuant to the provisions of section 124 of the Companies Act, 2013 read with the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, ("the IEPF Rules"), notified by the Ministry of Corporate Affairs effective September 7, 2016 in respect of which the dividend on equity shares remained unpaid or unclaimed for seven consecutive years or more are required to be transferred to the Demat Account of IEPF Authority.

In case there is no response and dividend amount(s) are not claimed on or before the due date, the Company shall without further notice, transfer the unpaid /unclaimed dividend and shares to the IEPF Suspense Account as per procedure stipulated in Rules. The Shareholders may take a note that subsequent to such transfers of the relevant shares to IEPF, all future benefits which may accrue thereunder, including the future dividends, if any, will be credited to IEPF.

However the Shareholders can claim back the unclaimed dividend amount and respective shares by following the procedure prescribed in the Rule 7. Please note that no claim shall lie against the Company with respect to the unclaimed dividends and share (s) transferred to the IEPF pursuant to the IEPF Rules.
